NOW THIS TRUST DEED WITNESSES AS FOLLOWS:-

1. In order to effectuate the said object of creating and establishing educational Public Trust, the settlers have contributed to the Trust a sum of Rs. 1,51,000/- that would represent the Trust estate together with all addition and all accretions thereto and all accumulated thereof and all other properties that may acquired out of the same or otherwise hereinafter be subject to (hereinafter referred to as the Trust Fund) for the objects enumerated as trust objects and purposes and used hereinafter expressed with the powers on the terms and conditions herein contained of the concerning the same.

I. The name of the Trust shall be SWAMI VIVEKANAND SOCIAL WELFARE AND EDUCATIONAL TRUST.

II. The office of the trust is situated at:- Vill. Sonpur Gai Bazar, P.O.& P.S.-Sonpur, Distt.-Saran.(Bihar), Pin-841101 which may be changed from time to time to such other place as the Founder/Trustees may deem fit and proper at their discretion.

III. The Trust may have its unit offices at any place in India and abroad.

IV. Founders who are Trustees also for the purposes declare that they will continue to be absolute in charge and pledge to stand by the decisions made by the Board of Trustees/Founders.

V. Object of the Trust:- The object of the Trust are to:-

- I. Establish, run, develop and manage Hospitals, Medical, school, Bachelor of Education, Pharmacy and dental colleges, nursing institutions dispensaries, technical or non-technical institutes such as, Engineering, polytechnic, software colleges,

child and woman welfare centers in India for the benefit and use of the general public.

II. Establish, run, develop and manage, assist and support schools, colleges, libraries, reading rooms, laboratories for research, and other institutions of the like nature in India for the development and advancement and diffusion of knowledge amongst the public in general.

III. Establish, run, develop and manage student scholarships and render of Aid to students including supply of books, stipends, medals and other incentive to study without any distinction as to caste, colors, race, creed or sex.

IV. Promote, establish, run and manage institutions for the promotion of science and technology, literature, music, drama and fine arts in India for the benefit of public in general.

V. Establish, run, maintain and manage for the establishment and/or maintenance of parks, gardens, gymnasium, sport clubs, dharmshalas and rest houses for the use by public in general.

VI. Establish, run, maintain and manage homes for the aged orphanages or other establishment for the relief and to help to the poor, needy destitute people, orphans, widows and aged persons.

VII. Establish, run, maintain and manage institutions or centers for the physically handicapped and mentally retarded persons and provide them education, food, clothing and other help.

Power of the Founders (the work "Founder/Trustee" used hereinafter stands for all the Founders/Trustees)

I. Founder(settler) shall appoint any employee i.e. Manager, Supervisor, Legal Advisor and Legal Assistant, Accountant, Cashier, Peon Chowkidar, etc. He also has powers to terminate the services of any staff as he may deem fit and proper for the benefit of the trust.

The process of nomination of successor shall continue till the working of the trust.

3. The Founder (Settler) Sri Ranbir Singh shall be the absolute in-charge of the Trust and will exercise all the discretionary and sovereign powers.

4. It is hereby declared that no part of the trust property or its income shall be utilized or spent temporarily or permanently in any purpose other than the object of the Trust as understood/assessed under the Income Tax Act, and the surplus funds, if any of the Trust shall be invested as per the provision of the Income Tax Act.

5. The number of Trustees shall not be less than three and not more than seven. The Trustees shall be Trustees for their life time but any Trustee may resign by giving his resignation in writing to the co-Trustees. Appointment of Trustee(s) shall be only with the final consideration, decision and approval of the settler or in case of his death, his nominee or successor(s)

6. General management and the control of the Trust property/asset and its affair shall be vested in the Trustees and the Trustees shall have power of perform all such acts as they may consider necessary and imperative for the benefit of the Trust, and management of its property and affairs thereof.

7. All the Trustees including Executive Trustee/Founder shall form the Board of Trustees, and all the decisions shall be taken in meeting of the Board called on scheduled dates. Without prejudice to any of the power that the Trustees may enjoy for a specific duration for a specific purpose, or the general power vested in them, the Trustees shall have the following additional powers:-

a. To manage the Trust and the trust fund, Trust property and other affairs relating to the Trust and to do all acts, its deed and things necessary for the preservation maintenance and management thereof, and the affairs relating thereto or connected therewith including the making of Rules and Regulations as and when the need arises.

- b. To apply any part of the fund in acquiring movable and immovable properties and sell, mortgage, alienate or otherwise dispose of the same as they may think fit and proper.
- c. To take on rent or lease, purchase or construct building and to construct, add, alter, demolish, maintain, sell, dispose of alienate or otherwise deal with any property movable or immovable comprising the Trust fund for the achievement of the objects of the Trust.
- d. To let out any movable or immovable property component of the Trust fund for a period and at a rent as the Trustee desire, thing fit and proper.
- e. To acquire, purchase, change, transfer transport or other wise deal with all or any of the investments including shares, stocks, debentures, Government sureties/securities belonging to the Trust or representing the Trust fund and to re-invest the same as the Trustees may deem and proper in accordance with provision of income tax act.
- f. To apply to get registered under the section 80-G (and also get/apply for other relaxation/exemption of the Income tax Account.
- g. To accept donation, contributions, gifts and/or other grant in aid either in money or in kind.
- h. To open accounts and give directions, endorse and sign Government securities, promissory notes, shares, debentures, securities instruments etc and all these accounts shall be operated by Trustees jointly and/or severally as decided by them (the Trustees) but the decision of the Founder/nominee(s) or the successor(s) shall be final.
- i. To appoint sub-committees comprising of one Trustee or more for carrying out objects and purposes of the Trust or matters connected with the Trust and/or its affairs.
- j. To institute suits, action and legal proceeding, to prefer appeals, to make application and petitions and to give affidavits, wherever necessary and to defend or compound compromise, arbitration, submit or arbitration or other wise settle any suit, action

- m. To amalgamate the Trust with other institutions, associations, trust or organization having public charitable objects and purposes with the consent of two-third of the Trustees in writing.
- n. to nominate, appoint and constitute Attorney(s), Legal practitioners, Agent etc to delegate the duties and power vested in them (Trustees) with regard to the management of the Trust property including starting or refunding of the legal proceedings or for opening or operating upon accounts with any bank(s) person(s) firm(s) or to do such other acts and duties relating to or connected with the Trust property as may be considered, deemed necessary by the Trustees.
- o. And generally to do all acts, deeds and things as may be necessary for the administration of the Trust.

8. It is hereby declared that no part of the Trust property or its income shall be applied for any purpose other than the objects of Trust as understood/explained under the Income Tax Act for the time being in force and the surplus funds if any of the Trust shall be invested as per the provisions of the Income Tax Act.

9. The number of Trustees shall not be less than three and not more than seven. The Trustees shall be Trustees for their life time but any Trustees may resign by giving in writing his resignation to the co-Trustees. Appointment of Trustees shall be only with the final approval of Settler/his nominee(s) or his successor(s).

11. The Trustees will not be entitled to receive the remuneration as trustees but may reimburse themselves of all expenses actually incurred by them in connection with the Trust or their dues thereto.

12. The Trustees may, time to time frame Rules for the conduct of the administration of the Trust and regulating the meeting of Trustee.

In the absence of such regulations:-

- a. All the matters shall be decided by the majority and the quorum for the meeting shall be two-third.
- b. A resolution circulated to all the Trustees and signed by the majority of such Trustees shall be as valid and effective as resolution duly passed at a meeting of the Trustees.

13. The regular account shall be maintained relating to all receipts payments, income, expenditure or any properties or liabilities relating to the Trust, Further the accounts of the Trust will be audited by a qualified chartered accountant.

14. The Board of the Trustees shall be entitled of sue in the name of the Trust and may similarly be sued in the name of the Trust.

15. All the provisions of Indian Trust act, 1882 shall be applicable to this Trust.

16. The dissolution of the Trust may be affected by a special resolution passed by a majority of two-third of the Trustees present at the special meeting convened for the purpose with the consent of the president of the Trust after satisfaction of all its debts and liabilities, any property whatsoever. The shall not be paid or distributed amongst the trustees of the Trust, but shall be given or transferred to some other like Institutions having same aims and objects to be determined by the Board of the Trustees at or before the time of dissolution.

WHEREAS the settler declared a Trust and the Trust deed was registered at Sub- Registry Office, Sonpur on dated 13th Day of September 2013, Volume No-1, Page No-144 to 154, Token No-3644, Deed No-IV 14.

AND WHEREAS the trustees resolved to apply for grant of Registration U/s 12AA of the Income Tax Act against which a deficiency letter received from Income Tax Department. It has been pointed out that there is no irrevocability clause in the Trust deed. There was no intention of the settler to revoke the trust in future. However in absence of a specific clause of irrevocability in the Trust deed there may be some different thought of the settler in future. Once the issue has been raised specific mention of irrevocability of the Trust is required to be inserted to clarify the intention of the settler. Accordingly Clause relating to irrevocability of Trust lacking in the Trust Deed requires supplementation. It was thought expedient to insert the following clauses in the trust deed by this supplementary Trust deed to avoid any unintended situation in future.

AND WHEREAS this is first amendment of the Trust deed since its registration on 13.09.2013 and this supplementary Trust deed shall remain attached with the original Trust Deed as an Attachment. Whenever the Trust deed is required to be produced or submitted before any authority this supplementary Trust deed shall remain attached with original Trust deed.

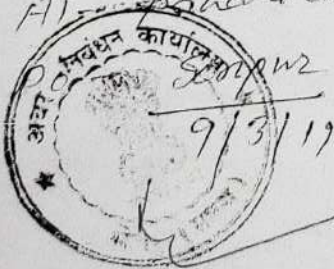
